SECTION 4: FIRST AID MEASURES.

4.1 Description of first aid measures.

Inhalation.

6.3 Methods and material for containment and cleaning up.

Pick up the spill with non-combustible absorbent materials (soil, sand, vermiculite, diatomite, etc.). Pour the product and the absorbent in an appropriate container.
